Minutes of Cherokee County Tourism Development Authority June 12, 2017

The Cherokee County Tourism Development Authority met at 2:00 p.m. on June 12, 2017 at the Murphy Visitor Center.

The meeting was called to order by Sandra Daley, after which there was a moment of silence and the pledge of allegiance.

Sandra Daley asked the Board members and guests in attendance to introduce themselves.

Gary Westmoreland made a motion to approve the agenda, seconded by Phylis Blackmon and unanimously adopted.

Steve Dickey made a motion to approve the May 8, 2017 minutes, seconded by Sandra Daley and unanimously adopted.

Josh Vaught made a motion to pay \$100.00 for a one-half page ad in the Western North Carolina Wagon Train magazine, seconded by Gary Westmoreland and unanimously adopted. Phylis Blackmon made a motion to enter into Executive Session, motion being seconded by Gary Westmoreland and unanimously adopted. After discussion, Steve Dickey made a motion to end Executive Session, motion being seconded by Gary Westmoreland and unanimously adopted.

Under public forum, Meridith Jorgenson discussed a co-op marketing opportunity with all regions of Western North Carolina for the cover page of the 2019 Official North Carolina Travel Guide. Aurelia Stone stated that the Cherokee County Chamber of Commerce and the Tourism Development Authority had separate agenda's regarding marketing.
