### Tax Preparation Assistance from Local Government Federal Credit Union

**Volunteer Income Tax Assistance\* (VITA) program**: If you are a member of the LGFCU and your 2015 household income was \$54,000 or less you may be eligible to have your standard income tax return prepared and filed at no cost to you.

**Low-Cost Tax Preparation Service**≠: If your 2015 household income exceeded \$54,000, you can have a standard income tax return prepared and filed in one of the Credit Union branches for only \$75.

Choose to have your return filed electronically and receive your refund as quickly as 8-15 days! Visit **lgfcu.org/taxprep** for more information and a list of what to bring with you when you go to your local branch.

Certain tax returns may fall outside the scope of these programs. Call the Contact Center at 888.732.8563 for additional information. Calls may be recorded for quality assurance.

\*VITA is an IRS-sponsored program available to help taxpayers with a household income of \$54,000 or less prepare and electronically file basic tax returns.

#The Credit Union's fee-based tax preparation program is not affiliated with the VITA program.

However, remember there were 27 pay days last year so if you were close, you may not need to make changes to your withholding for this year. We normally only have 26 pay periods per year.

There is something about the winter months and curling up with a good book by the fireplace. But did you know that heating equipment is one of the leading causes of home fire deaths? With a few simple safety tips and precautions you can prevent most heating fires from happening.

#### BE WARM AND SAFE THIS WINTER!

- Weep anything that can burn at least three-feet away from heating equipment, like the furnace, fireplace, wood stove, or portable space heater.
- ))) Have a three-foot "kid-free zone" around open fires and space heaters.
- Never use your oven to heat your home.
- Where a qualified professional install stationary space heating equipment, water heaters or central heating equipment according to the local codes and manufacturer's instructions.
- ))) Have heating equipment and chimneys cleaned and inspected every year by a qualified professional.
- Remember to turn portable heaters off when leaving the room or going to bed.
- Always use the right kind of fuel, specified by the manufacturer, for fuel burning space heaters.
- Make sure the fireplace has a sturdy screen to stop sparks from flying into the room. Ashes should be cool before putting them in a metal container. Keep the container a safe distance away from your home.
- >>> Test smoke alarms monthly.



## Heating Equipment Smarts

Install wood burning stoves following manufacturer's instructions or have a professional do the installation. All fuel-burning equipment should be vented to the outside to avoid carbon monoxide (CO) poisoning.

Install and maintain CO
alarms to avoid the risk
of CO poisoning. If
you smell gas in
your gas heater, do
do not light the
appliance. Leave the
home immediately
and call your local fire
department or gas company.
