Good Morning,

The Detention Center currently has 2 commercial washing machines. One was purchased on 2/13/2008 and one was purchased on 6/11/2024. The one purchased on 2/13/2008 is broken down. The broken washer is 17 years old and the repair estimate is 1/3 the cost of purchasing a new one. It is our recommendation that we purchase a new washer for \$18,547 (see quote attached).

Since the Detention Center currently only has 1 operating washing machine, this puts additional wear and tear on that one operating washing machine. In addition, if the current operating washing machine has an issue, the Detention Center would be forced to ship out laundry until it could be repaired.

We are requesting pre-approval from Commissioners to go ahead and order the new washing machine. If each of you could please text or call Darryl (828-361-4507) with a "yes" or "no" to order the new washing machine. If we have a majority to approve, we can let the Detention Center know they can move forward with the purchase. I will present the formal budget revision for the purchase at your next meeting.

 - 1. Determine design wind loads in accordance with ASCE 7 as required by the current edition of the State Building Code.
 - 2. Primary and secondary (overflow) drainage for compliance with the current edition of the State Plumbing Code.
 - 3. Existing and proposed roof system R-Value for compliance with the current edition of the State Energy Conservation Code.
 - 4. Estimate existing and proposed roof system dead load unit weights to determine load change and the need for a structural analysis. If a structural analysis is required, REI will coordinate applicable work with a licensed Structural Engineer. The cost for the structural analysis (if necessary) is not included in this proposal.
- D. Prepare comprehensive scale drawings for conditions present to ensure competitive bids are received. All plans and details to be developed on Computer Aided Drafting (AutoCAD).

- E. Prepare technical specifications for the project.
- F. Issue preliminary Contract Documents for Owner and DPI review. Upon acceptance, final Contract Documents will be prepared and submitted.
- G. Provide advertisement for bids to Owner for use in advertising in accordance with applicable laws and/or submit names of three or more qualified Contractors to bid the Contract Documents.
- H. Hold one Pre-Bid Meeting for potential contractors to review the Contract Documents and resolve any questions that may arise during the bid stage of the project.
- I. Bids shall be analyzed and a recommendation made based on low bid, alternates, contractor's past performance and Owner's budget restrictions. Submit a certified Bid Tabulation and recommendation for award.

II. CONSTRUCTION ADMINISTRATION

- A. Complete Owner's recommended Form of Agreement between Owner and Contractor and submit to Owner and Contractor for acceptance.
- B. Issue "Notice to Proceed" with Date of Commencement and construction period established.
- C. Review and accept submittals required by the Contract Documents, to determine if the items covered by the submittals comply with the requirements of the Contract Documents and are compatible with the design concept of the completed Project. Such reviews and acceptances or other action will not extend to means, methods, techniques, sequences or procedures of construction. Return unacceptable submittals to contractor as required until compliance with specifications is realized. Two reviews of each submittal are included in this proposal.
- D. Hold a pre-construction meeting with the successful contractor to ensure a clear understanding of the plans and specifications.
- E. Construction Observations:
 - 1. Perform construction observation site visits once every five working days, Monday through Friday, to verify work is in compliance with the Contract Documents. Photographs will be taken as deemed necessary for documentation. REI cannot comment on work that takes place and covered while REI is not onsite.
 - 2. Provide a report summarizing general observations and any significant findings.
 - 3. REI will not, during such visits or as a result of such observations, supervise, direct or have control over the work, nor will REI have authority over or responsibility for the means, methods, techniques, sequences, procedures, security or safety of construction selected or used by the Contractor.
- F. Review Contractor's applications for payment and recommend amount of payment to Contractor by Owner based on status of work performed as determined from project site visits.
- G. Route any change orders developed to address changes to the contract requirements.

- H. Upon notification by the contractor that the job is substantially complete, visit the site with Owner, Contractor and Manufacturer personnel to determine the status of completion. A punch list will be prepared to list any minor items that require further treatment.
- I. Upon notification by the contractor that the job is fully complete, visit the site with contractor and Owner personnel to determine if the work is in fact complete and acceptable. Issue notice of final completion or if necessary, an additional punch list will be prepared.
- J. Receive from Contractor, review and transmit to the Owner warranties and other documentation required by the Contract Documents.
- K. Prior to expiration of the Contractor's warranty, conduct a site visit to ascertain whether any portion of the work is defective and subject to correction by Contractor.

III. DRAINAGE INVESTIGATION

- A. Perform initial site visits to review current conditions. Document conditions and review owner documents.
 - 1. Assess all the stormwater discharge points to determine the current condition.
 - 2. Perform CCTV pipe inspections on the below grade drain lines to the point of restriction.
 - 3. Perform CCTV pipe inspections on the roof drain lines to the point of restriction.
- B. Perform a visual survey at reasonably accessible, exposed surfaces of the Stormwater components to locate specific problems and assess the overall needs of the components in question.
 - 1. Visual observation to occur from ground level or adjacent roof level.
 - 2. A licensed contractor will be utilized for remote camera inspections of the stormwater system.
- C. Photographs will be taken as necessary to document our observations.

REPORT

- A. Provide a report sealed by a North Carolina Licensed Professional Engineer outlining the results of our assessment.
- B. Based on conditions determined through careful review of the Stormwater components, an outline of necessary or desired remedial procedures will be provided.
- C. The recommended corrective actions will be outlined with the estimated cost of the work.

IV. PROPOSED SCOPE OF WORK

- A. 1952 Wing (Area A): Remove existing roof system down to the existing insulation, (Provide additional tapered insulation if the existing storm water system cannot be made reasonably operable) and a new roof system along with sheet metal flashing and accessories, re-distribute the existing ballast and provide additional as required to provide a complete, watertight, 20-year warrantable roof assembly. Roof system selected will be submitted to Owner for approval.

- B. 1972 Wing (Area B, C, & D): Remove existing roof system(s) down to the existing structural deck and provide new PVC roof system along with sheet metal flashing and accessories to provide a complete, watertight, 20-year warrantable roof assembly. Roof system selected will be submitted to Owner for approval.
- C. Drainage Investigation: Conduct visual assessment of underground storm drainage. After investigation and identification of drainage deficiencies, a proposal will be submitted for designing solutions.

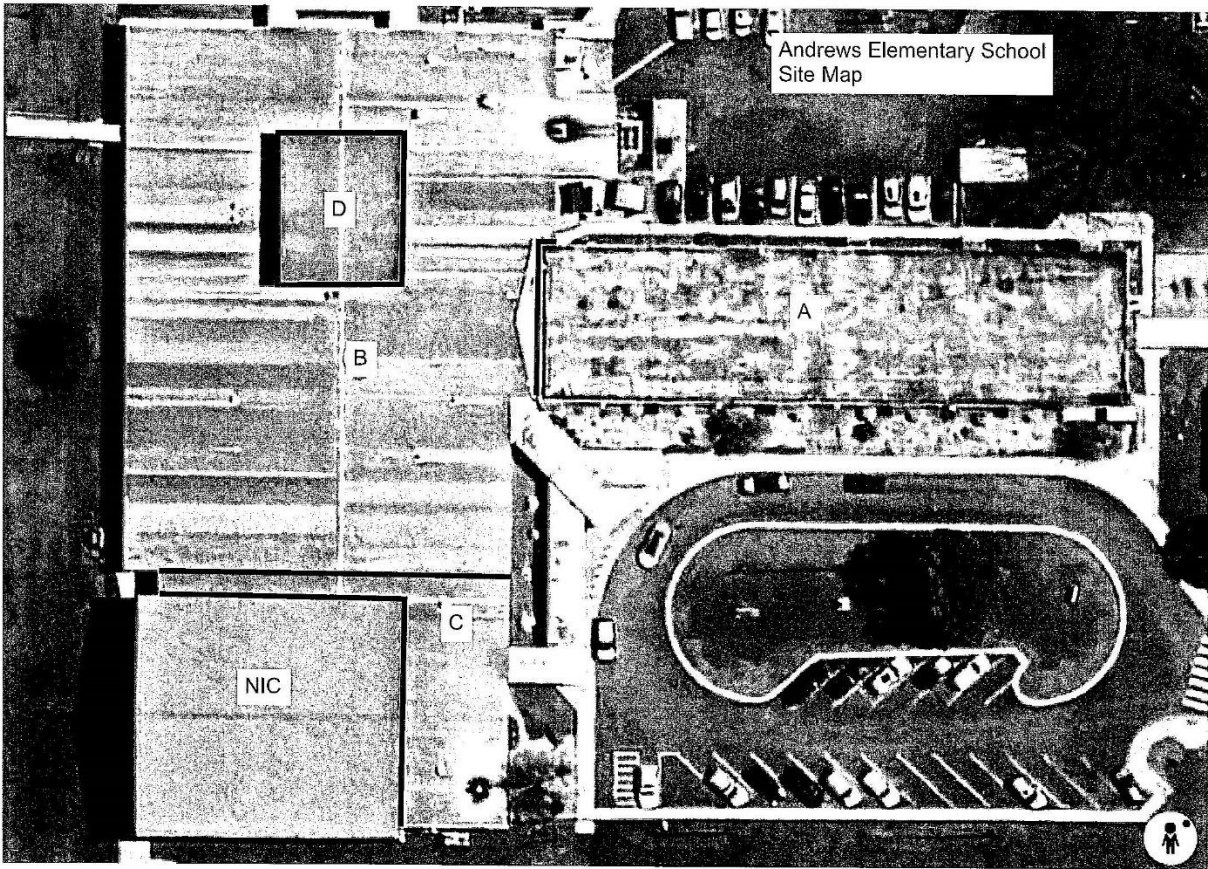

ENGINEERING SERVICES AGREEMENT

THIS ENGINEERING SERVICES AGREEMENT ("Agreement") made and entered this ___ day of _____ 2026 ("Effective Date"), by and between **CHEROKEE COUNTY BOARD OF EDUCATION**, a body corporate and governmental located at 2230 Airport Road, Marble, NC 28905 ("Owner") and **CHEROKEE COUNTY**, a body politic and corporate located at 75 Peachtree St., Murphy, NC 28806 ("Authorized Payor") and **REI ENGINEERS, INC.**, a North Carolina corporation located at 1927 JN Pease Place, Suite 201, Charlotte, NC 28262 ("Engineer") (collectively "Parties").

WHEREAS, Owner, through an advertised, request for qualifications selection process in accordance N.C.G.S. § 143-64.31, selected and retained Engineer to provide professional consulting, engineering services and construction administration for the Andrews Elementary School Roof Replacement and Drainage Evaluation ("Project");

WHEREAS, Owner is responsible for administering and overseeing the Project and Authorized Payor is the responsible party to pay for the Project;

WHEREAS, a copy of Engineer's January 9, 2026 proposal ("Proposal") is incorporated herein and attached hereto as Exhibit A. If there are any conflicts between Exhibit A and this Agreement, this Agreement shall control; and

WHEREAS, Engineer desires to provide such professional consulting and engineering services for the Project as may be agreed to by the Parties in accordance with this Agreement.

NOW, THEREFORE, in consideration of the mutual covenants and benefits contained herein, it is hereby mutually understood and agreed as follows:

SECTION 1 – SERVICES, COMPENSATION AND SCHEDULE

1.1 SERVICES

1.1.1 This Agreement shall apply to the Project and shall govern all the Project's phases.

1.1.2 In performing services pursuant to this Agreement, Engineer shall comply with all applicable laws, rules, regulations, ordinances (including the Town of Andrews' zoning ordinance), codes, standards, and orders of any and all Authorities Having Jurisdiction ("AHJs") at the Site. Engineer's design plans and specifications shall meet the requirements of the North Carolina Building Code, the Department of Insurance of the State of North Carolina, the North Carolina Department of Labor, the U.S. Army Corps of Engineers, Federal Emergency Management Agency, the North Carolina Department of Emergency Management, the North Carolina Department of Environment Quality, the North Carolina Department of Public Instruction, and all applicable federal, state and local laws and regulations including the Americans with Disability Act and federal and state Occupational Safety and Health Acts.

1.2 COMPENSATION

1.2.1 For Basic Services, as defined in Section 2 herein, related to the roof replacement portion of the Project, Engineer shall be paid by Authorized Payor the sum of Forty-Six Thousand Nine Hundred Forty-Eight Dollars (\$46,948.00). Payment for said services shall be made as indicated in this Section and as stated in Section 6.5.

1.2.2 Payments for Engineer's Basic Services for the roof replacement portion of the Project shall be made monthly, except for the final one percent (1%) of the fee for Basic Services, in proportion to services performed so that the following percentages of the total fee for Basic Services will have been paid at the completion of each phase as follows:

Payment of the final one percent (1%) of the total fee for Basic Services will be made to Engineer at Final Completion when final acceptance of the Project is made in writing by Owner, upon the closing of all construction contracts and after the submission to Owner of all documents as required in Section 2.5 and any other services as required in the Post-Construction Phase (except Section 2.5.7).

1.2.3 In addition, Owner shall pay to Engineer the sum of Twelve Thousand Eight Hundred Ninety dollars (\$12,890.00) for Engineer's drainage investigation portion of the Project. A lump sum payment for said services shall be made to Engineer within thirty (30) days upon receipt of the written report from Engineer.

1.3 SCHEDULE

1.3.1 Preliminary Contract Documents shall be completed within sixty (60) days of the Effective Date of this Agreement. Final Contract Documents shall be completed and sealed within fourteen (14) days of receipt of comments.

1.3.2 Construction Administration shall be performed during the estimated construction duration and the Project Post-Construction Phase. This work is expected to take one hundred twenty (120) calendar days after Owner issues Contractor a Notice to Proceed.

SECTION 2 - BASIC SERVICES

The agreed Basic Services are those services listed in Exhibit A in addition to the following other services described in this Section.

2.1 PRELIMINARY PHASE

2.1.1 Consult with Owner to fully determine Owner's requirements for the Project and to discuss the possible phasing, coordination, approvals, and other preliminary matters.

- 2.1.2 Coordinate and conduct initial coordination meeting(s) with any other applicable parties as needed for the purpose of establishing communication lines, meet project team members and define project schedules, coordinate various plans and improvements, and discuss pertinent matters related to the Project.
- 2.1.3 Prepare a preliminary opinion of probable project costs and a written narrative memorandum of the technical scope of the Project resulting from the preliminary determinations to assure a good understanding and coordinate such information with Owner.

2.2 DESIGN PHASE

- 2.2.1 Prepare the complete bid documents, contract documents, technical specifications, and construction drawings to detail the character and scope of the Work including all design functions, surveying, and coordination for all construction sequencing of the Project as determined in the Preliminary Phase.
- 2.2.2 Review all the design documents as described above with Owner for comments and approval throughout the design process.
- 2.2.3 Assist Owner in securing approval of the final design documents from such AHJs over the Project or any portion thereof, such as encroachment on NCDOT rights-of-way, sedimentation and erosion control plans, water and sewer system, etc. Engineer shall, with the approval of Owner, make such changes in the construction documents as may be recommended or required by said AHJs without additional expense to the Owner.
- 2.2.4 Provide field surveys and legal descriptions to assist Owner in obtaining any right-of-way easements or encroachment agreements from public bodies, entities, or persons necessary for satisfactory construction of the Project.
- 2.2.5 Engineer shall coordinate the services provided by any firms conducting subsurface or structural investigations or other types of construction materials testing and analysis needed for proper design. The provision of such services including subsurface, geotechnical, special inspections and materials testing, should they be required, shall be paid for by Owner and contracted directly between Owner and the consultant providing such services.
- 2.2.6 Advise Owner of any adjustment of Project cost caused by changes in scope, design requirements or construction costs and furnish a revised opinion of probable construction cost based on the final design documents.
- 2.2.7 Furnish copies of the final design documents as required to accomplish the design phase.
- 2.2.8 Engineer shall place their seal, name and signature on the final design documents prepared by them.
- 2.2.9 Engineer shall not commence to any further phase until the Owner has formally approved the construction documents and has allocated sufficient funds to pay for engineering services through receipt of bids.

2.3 BIDDING AND AWARDING PHASE

- 2.3.1 Assist Owner in advertising, receiving, opening, and evaluating bids in accordance with the North Carolina General Statutes. Owner shall pay costs associated with Project advertising and bid solicitation.
- 2.3.2 Consult with and advise Owner as to the acceptability of contractors and subcontractors and make recommendations as to the lowest, responsive, responsible, bidder.
- 2.3.3 Assist Owner in the final preparation and execution of construction contracts and in checking required performance and payment bonds and certificates of insurance for compliance.
- 2.3.4 Schedule a preconstruction conference with Owner, Contractor, Engineer and all other applicable parties to ensure discussion of all matters related to the Project.

2.4 CONSTRUCTION ADMINISTRATION PHASE

- 2.4.1 Engineer will perform construction observations at the Site at least once every five (5) working days and will make such other periodic visits to the Site as necessary to enable Engineer to familiarize itself with the progress and quality of the Work and to determine and report to Owner whether the Work is proceeding in accordance with the Contract Documents. During such visits and based on Engineer's observations while at the Site, Engineer will keep Owner informed of the progress of the Work, will endeavor to guard Owner against deficiencies in the Work and may condemn Work as failing to conform to the Contract Documents. Engineer will promptly provide written reports to Owner following each construction observation at the Site.

If Owner requires more extensive representation at the Site, Engineer shall be compensated in the form of Additional Services.

- 2.4.2 Based on such observations outlined in Section 2.4.1, and Contractor's written and detailed applications for payment, Engineer will determine the amount owing to Contractor and will issue certificates for payment in such amounts. These certificates will constitute a representation to Owner, based on such observations and the data comprising the application for payment, that the Work has progressed to the point indicated. By issuing a certificate for payment, Engineer will also represent to the Owner that, to the best of Engineer's knowledge, information and belief based on what Engineer's observations have revealed, the quality of the Work is in accordance with the Contract Documents.
- 2.4.2 To the extent provided by the Agreement between the Owner and Contractor and/or applicable law, Engineer shall make decisions on all claims of Owner and Contractor and on all other matters relating to the performance of the Contract Documents and the execution and progress of the Project or the interpretation of the Contract Documents. Engineer shall review samples, substitutions, schedules, shop drawings, requests for information/instructions, requests for change orders, and other submittals requests and communications of contractors, subcontractors, manufacturers, machinery and equipment suppliers, computer hardware, software, and systems suppliers, and material suppliers for conformance with the design concept of the Project and for compliance with the information given by the Contract Documents. Engineer shall prepare construction field directives, prepare change orders, shall assemble and deliver to Owner written warranties

and guarantees required of the Contractor and operation and maintenance manuals and instructions to Owner.

- 2.4.3 Upon Owner's request, Engineer will make a written determination whether there has been a delay in completion of the Project in accordance with Contract Documents due to the fault of one or more of the Contractors. If the Engineer determines that there has been a delay due to the fault of one or more of the Contractors, Engineer shall identify: (a) the contractor(s) whose fault cause the delay; (b) the length of the delay in number of days; and (c) if necessary, the relative contribution of each Contractor to the delay.
- 2.4.4 Engineer will conduct inspections to assist Owner in determining the dates of Substantial Completion and Final Completion and, after Engineer's final inspection prior to Final Completion, issue a Final Certificate for Payment. Before issuing a Final Certificate for Payment, Engineer will assemble all documents required by the Contract Documents and all documents required for final payment (see Section 2.5), all of which shall be provided to Owner with Engineer's Final Certificate for Payment. Engineer will promptly provide written reports to Owner following each construction conference at the Site and following each Site observation performed by Engineer.

2.5 POST-CONSTRUCTION PHASE

- 2.5.1 Prepare for Owner a set of reproducible record prints of drawings showing those changes made during the construction process, based on the marked-up prints, drawings and other data furnished. The provision of surveyed "as built" will be considered Additional Services.
- 2.5.2 Provide or make available all Project files and information to effect Project close-out.
- 2.5.3 Assemble and provide to Owner all written warranties related to the Project.
- 2.5.4 Issue Certificate of Substantial Completion.
- 2.5.5 At Final Completion, issue a Final Certificate of Payment based on Engineer's inspection that, based on information and belief, the Work complies with the Contract Documents.
- 2.5.6 Prior to issuance of Final Completion, issue Owner's required document entitled "Final Certificate and Release" to Contractor for execution as a condition precedent to Final Certificate for Payment.
- 2.5.7 During the tenth (10th) month after the date of Substantial Completion, Engineer shall, without additional compensation, conduct a meeting with Owner to review the Project. Prior to the meeting, Owner shall endeavor to provide a written list of known issue and concerns to Engineer to be discussed and address at the meeting. Engineer shall prepare a report indicating outstanding Work or deficiencies in the Work to be corrected by Contractor. Engineer shall provide a copy of the report to the Owner and, at the Owner's discretion, the Contractor. Upon Owner's request and as Additional Services, Engineer shall assist Owner in taking the necessary action to see that the deficiencies are corrected.

SECTION 3 - ADDITIONAL SERVICES

If authorized by Owner, Engineer will furnish or obtain from others Additional Services of the following types which are not considered Basic Services under this Agreement.

- 3.1.1 Additional services resulting from significant changes in general scope of a Project or Task Order, its design including, but not limited to, changes in size, complexity, Owner's schedule, or character of construction including provision of on-site observation and construction administration services rendered by Engineer beyond the original duration of the established construction time for the Contractor constructing the project
- 3.1.2 Revising previously approved studies, reports, design documents, drawings, or specifications, when such revisions are due to causes beyond the Engineer's control.
- 3.1.3 Preparing documents for alternate bids requested by Owner for work which is not executed or documents for out-of-sequence work other than agreed upon in the Preliminary Phase.
- 3.1.4 Services in connection with Change Orders to reflect changes requested by Owner if the resulting change in compensation for Basic Services is not commensurate with the Additional Services rendered.
- 3.1.5 Additional or extended services during construction made necessary by prolongation of the construction contract or default by the Contractor under any prime construction contract if such construction contract is delayed beyond the original completion date; provided, however, that Engineer shall not be compensated for pre-existing Basic Services which have not yet been performed including: a) close-out related services necessary for the Project Final Completion; and b) assisting Owner in the preparation of the Final Certificate and Release to be executed by the Contractor prior to Final Completion. Prior to commencing any extended contract services, Engineer shall provide Owner with a reasonably detailed written description of Owner's estimation of the remaining Basic Services to be provided. Engineer shall not proceed to provide any extended construction services until Engineer receives Owner's written approval to proceed. If extended contract services are due to Engineer's partial fault, Owner shall prorate the amount owed, based on Engineer's proportionate fault. In the event Engineer disagrees with Owner's determination of entitlement to extended contract services, or its determination of pro-ration of fees, Engineer will provide the services subject to a reservation of rights and does not waive any contractual rights under this Agreement.
- 3.1.6 Preparing to serve or serving as a witness for Owner in any litigation, condemnation or other legal or administrative proceeding involving the Project.
- 3.1.7 Additional Services in connection with the Project, including services normally furnished by Owner and services not otherwise provided in this Agreement.
- 3.1.8 Assistance with property acquisition, easements or rights-of-way and preparation of easement map(s) not specifically included in the task of Work.
- 3.1.9 Provision of G.I.S. or surveying services for As-Builts (record drawings).
- 3.1.10 Provision of special inspections, geotechnical or subsurface investigations, and construction materials testing during design and construction phases.
- 3.1.11 Prior to commencement of and compensation for any Additional Services, Engineer must notify Owner in writing that such Additional Services will be necessary and shall obtain Owner's written approval to either a mutually agreeable: 1) lump sum amount; or 2)

hourly fee arrangement for the specific scope of work. Unless otherwise specified herein, Engineer's current hourly rates are established in Exhibit B. All time shall be rounded to the nearest quarter hour. Payment for any such Additional Services shall be made by Authorized Payor from time to time upon presentation of Engineer's detailed invoice showing at a minimum the date, a description of the specific activity and the time spent, rounded to the nearest quarter hour. Authorized Payor shall not pay for Additional Services not approved in advance as required herein.

SECTION 4 – OWNER'S RESPONSIBILITIES

Owner is the Cherokee County Board of Education, a body corporate and governmental. Owner, by majority vote of its Board, is the only entity having the power to enter and amend the Agreement, unless such authority is specifically granted by the Board to its authorized representative. Owner may designate in writing one or more persons to represent it with respect to the day-to-day activities of the Project; however, such representatives shall have the authority to bind Owner only to the extent expressly authorized by Owner and shall have no implied authority.

Authorized Payor is Cherokee County, a body politic and corporate. Upon Owner's approval, Authorized Payor shall pay directly to Engineer its compensation and additional expenses, as approved herein, for this Project. All payments shall be made subject to the project ordinance approved by the Cherokee County Board of Commissioners.

Owner shall:

- 4.1.1 Provide full information as to its requirements for the Project.
- 4.1.2 Subject to the preamble in this Section, designate a person to act as Owner's authorized representative with respect to the Work to be performed under this Agreement; and such person shall have complete authority to transmit instructions, receive information, interpret, and define Owner's policies and decisions with respect to materials, equipment, elements and systems pertinent to the services covered by this Agreement.
- 4.1.3 Assist Engineer by placing at its disposal all available information pertinent to the Project including previous documents and any other data relative to evaluation, design, and construction of the Project.
- 4.1.4 Furnish Engineer any existing data and information for property boundary, easement, right-of-way, operating information, previous construction plans, topographic and utility surveys; zoning and deed restriction; all of which the Engineer may rely upon in performing his services under this Agreement.
- 4.1.5 Guarantee access to and make all provisions for Engineer to enter upon public and private property as required for Engineer to perform his services under this Agreement.
- 4.1.6 Examine all studies, reports, sketches, estimates, specifications, drawings, proposals, and other documents presented by Engineer and render decisions and comments pertaining thereto within a reasonable time so as not to delay Engineer's services.
- 4.1.7 Owner, by and through Authorized Payor, pay for all incidental costs to conducting subsurface or structural investigations or other types of construction materials testing and

analysis needed for proper design and construction of the Project. The provision of such services including subsurface, geotechnical, special inspections and materials testing, should they be required, shall be paid for by Authorized Payor and contracted directly between Owner/Authorized Payor and the consultant providing such services, unless otherwise agreed to by Engineer. Owner, by and through Authorized Payor, shall pay all costs associated with advertising, soliciting bids or proposals from Contractors.

- 4.1.8 Provide such legal, accounting and insurance counseling services as may be required for the Project, and such auditing services as may be required to ascertain how or for what purpose any Contractor has used the monies paid to him under the construction contract.
- 4.1.9 Give prompt notice to Engineer whenever Owner observes or otherwise becomes aware of any deficiency in design or defect in the Project.
- 4.1.10 Furnish approvals and permits from all AHJs over the Project and such approvals and consents from others as may be necessary for completion of the Project, subject to the obligations of Engineer outlined in Section 2.2.3 of this Agreement.
- 4.1.11 Furnish or direct Engineer to provide necessary Additional Services as stipulated in Section 3 of this Agreement or other services as required.
- 4.1.12 Bear all costs incident to compliance with the requirements of this Section 4.

SECTION 5 – PROJECT CONSTRUCTION COST

- 5.1.1 The Project Construction Cost means the total cost to Owner of all base bid work by all Contractors in the execution and completion of the Project, as designed and specified by Engineer, including contingency but not including payments to the Engineer for Basic Services. The Estimated Project Construction Cost is Four Hundred Forty-Two Thousand Dollars (\$442,000.00). The breakdown of the Estimated Project Construction Cost is as follows:
 - a. Construction Cost 1952 Wing (Area A)..... \$200,000.00
 - b. Construction Cost 1972 Wing (Areas B, C, D)..... \$205,000.00
 - c. Alternate #1 – Masonry on 1952 Wing..... \$7,000.00
including boiler chimney
 - d. Alternate #2 – Cast-in-place concrete canopy.....\$10,000.00
structures on 1952 Wing
 - e. Contingency Allowance.....\$20,000.00
- 5.1.2 In the event the total of the lowest responsible base bids of Contractors for the execution and completion of the Project exceeds the amount of funds available as determined by Owner, Engineer shall once again perform those services described in Article 2 of this Agreement in an effort to bring the Project Construction Cost within said amounts of funds available, and Engineer shall not receive or be entitled to any additional compensation therefor.
- 5.1.3 In the event the total of the lowest responsible base bids of Contractors for the execution and completion of the Project exceeds the funds available as determined by Owner, Owner, at its option, may negotiate with the Contractor submitting the lowest responsible bid in an effort to bring the Project Construction Cost within said amount of funds

available, but any such negotiation shall not relieve Engineer of the obligation imposed upon him by Paragraph 5.1.2 of this Agreement. Engineer shall participate in such negotiations on behalf of Owner and shall make any necessary changes in the plans, drawings, and specifications without additional compensation.

SECTION 6 – GENERAL CONDITIONS

6.1 SCOPE OF SERVICES

Engineer shall render professional consulting services to Owner as set forth in this Agreement.

6.2 STANDARD OF CARE

Engineer will perform its services using that degree of skill and diligence normally employed by professional engineers or consultants performing the same services at the time, place and condition these services are rendered.

6.3 AUTHORIZATION TO PROCEED

Execution of this Agreement and by Owner will be considered authorization to proceed only for the scope of work specific herein.

6.4 CHANGES IN SCOPE

Owner may request changes in the scope of services. If such changes affect Engineer's cost or time required for performance of the services, an equitable adjustment may be made through an amendment to this Agreement.

6.5 PAYMENT OF COMPENSATION

- 6.5.1 Owner, by and through Authorized Payor, shall pay compensation to Engineer for services rendered as set forth in Section 1.2.
- 6.5.2 Engineer shall submit invoices to Owner and Authorized Payor monthly for Work accomplished under this Agreement and Authorized Payor agrees to make full payment to Engineer within sixty (60) days of receipt of the invoices. It is also mutually agreed that should Authorized Payor fail to make prompt payments as described herein, Engineer reserves the right to immediately stop all Work under this Agreement until disputed amounts are resolved.
- 6.5.3 Additional Services shall be compensated pursuant to Section 3.1.11. If the Parties agree upon hourly compensation, such compensation shall be based on the hourly rates established in Exhibit B.
- 6.5.4 The hourly billing rates for services of Engineer and Engineer's consultants are set forth in Exhibit B. These rates may be adjusted no more than once annually, effective for the entire calendar year, to reflect normal compensation and expense adjustments in Engineer's and Engineer's consultants' offices. Any such adjustment shall not exceed the percentage change in the U.S. Bureau of Labor Statistics Employment Cost Index (ECI) for Professional and Related Services, or if that index is no longer published, a comparable index reflecting professional service labor cost escalation. If there are

changes in Engineer and the Engineer's consultants hourly rates, Engineer shall provide a copy of the updated hourly rates at least one (1) month prior to the rate increase. Engineer is not entitled to a mark-up for its consultant's fees.

6.5.5 Reimbursable Expenses include actual expenditures made by Engineer in the interest of the Project. Owner shall reimburse the following expenses only:

- a. Authorized travel by Engineer, other than between Engineer's home office and Project Site, and only if the travel is in excess of fifty (50) miles. Travel shall be reimbursed based on the approved IRS mileage rate the time the travel is completed.
- b. Cost of printing and mailing of all sets of working documents and specifications required by AHJs that cannot be otherwise submitted electronically.
- c. If authorized by Owner in advance, the expense of overtime work requiring higher than regular rates.
- d. Renders, models and mock-ups, not otherwise required herein, that are requested by Owner provided, however, that Engineer will create, free of charge, basic presentation materials to present to Owner if requested.
- e. The aggregate of all reimbursable expenses shall be capped at one- and one-half percent (1.50%) of the Basic Services fee established herein.

6.6 PERSONNEL

Engineer represents that it has, or will secure at its own expense, all personnel required to perform the services under this Agreement, except those noted as Additional Services or beyond the scope of this Agreement, and that such personnel will be fully qualified and adequately supervised to perform such services. It is mutually understood that should the scope of services require outside subcontracted services, Engineer may do so at their discretion.

6.7 OPINIONS OF PROBABLE CONSTRUCTION COST

Any cost estimates provided by Engineer shall be considered opinions of probable costs. These along with project economic evaluations provided by Engineer will be on a basis of experience and judgment, but, since Engineer has no control over market conditions or bidding procedures, Engineer cannot warrant that bids, ultimate construction cost, or project economics will not vary from these opinions.

6.8 TERMINATION

6.8.1 Termination by Owner for Convenience. This Agreement may be terminated by Owner upon seven (7) days' written notice for any reason or no reason at all. Engineer shall be paid, as its sole remedy, accepted and approved Basic Services, Additional Services and Reimbursable Expenses, if any, reasonably incurred up to the date of termination.

6.8.2 If either Party believes the other Party is in default of any of the obligations and requirements under this Agreement, the non-defaulting party may send written notice of

default to the defaulting party with a seven (7) day cure period. If the defaulting party does not cure the default within the seven (7) day cure period, the non-defaulting party may terminate the Agreement with written notice to the non-defaulting party. In the event Owner terminates the Agreement, Engineer shall be paid, as its sole remedy, accepted and approved Basic Services, Additional Services and Reimbursable Expenses, if any, reasonably incurred up to the date of termination.

- 6.8.3 Owner may elect at any time to suspend the Project and Owner shall provide Engineer with written notice thereof. This Agreement shall automatically terminate, at Owner's election, if Owner suspends the Project and such suspension lasts more than six (6) consecutive months. In the event Owner suspends or terminates this Agreement, Engineer shall be paid, as its sole remedy, accepted and approved Basic Services, Additional Services and Reimbursable Expenses, if any, incurred up to the date of suspension or termination.
- 6.8.4 It is Owner's expectation that David Honeycutt shall be the principal Engineer for the Project, and if s/he shall die, become incapacitated, cease to be employed by Engineer or for any other reason cease to be the principal Engineer for the Project, Owner may terminate this Agreement upon seven (7) days' written notice to Engineer and Engineer shall be paid, as Engineer's sole remedy, approved Basic Services, Additional Services and Reimbursable Expense incurred up to the date of termination.

6.9 ASSIGNABILITY

This Agreement shall not be assigned or otherwise transferred by either Engineer or Owner without the prior written consent of the other Party.

6.10 OWNERSHIP OF DOCUMENTS

The intellectual property contained in documents, calculations, drawings, maps, and other items generated during the performance of services by Engineer shall remain the Engineer's property. The foregoing notwithstanding, Engineer grants Owner a non-revocable license to use the deliverables in any manner it sees fit in connection with the intended Project. Use beyond the intended Project is prohibited. Engineer shall assume no liability for inappropriate use of the deliverables.

6.11 INDEMNIFICATION

To the fullest extent permitted by applicable law, Engineer shall indemnify and hold harmless Owner and Authorized Payor, and Owner and Authorized Payor's officers, directors, members, partners, agents, consultants, and employees, from losses, damages, and judgments (including reasonable consultants' and attorneys' fees and expenses, include those incurred by Owner) arising from third-party claims or actions relating to the Project, provided that any such claim, action, loss, damages, or judgment is attributable to bodily injury, sickness, disease, or death, or to injury to or destruction of tangible property (other than the Work itself), including the loss of use resulting therefrom, but only to the extent caused by any negligent act or omission of Engineer or Engineer's officers, directors, members, partners, agents, employees, or consultants.

6.12 INSURANCE

- 6.12.1 Engineer shall provide and maintain, at its own expense, during the term of this Agreement the insurance noted herein covering its operations. Evidence of such insurance shall be delivered to Owner on or prior to the Effective Date of this Agreement. The certificate of insurance shall be on the latest approved North Carolina Department of Insurance Acord Form 25. The certificate of insurance shall certify that the insurance policies required herein are in force as of the commencement of the Agreement and certifying that these policies will not be cancelled during the Agreement other than by an endorsement added to the policies reading substantially as follows: "The policies herein referred to are not cancelable or subject to reduction of coverage by the Insurer unless the Cherokee County Board of Education has received thirty (30) days prior written notice via registered or certified letter." Certificates of insurance containing disclaimers holding Engineer harmless for failure to notify Owner of Engineer's policy cancellations will not be acceptable and should be modified to delete such disclaimers from the insurance certificates. Receipt of the certificate of insurance is a condition precedent to this Agreement and said certificate is attached as Exhibit C.
- 6.12.2 Automobile Liability. Bodily injury and property damage liability insurance covering all owned, non-owned, and hired automobiles for limits for bodily injury of not less than \$1,000,000 per person and \$2,000,000 per accident, and property damage limits of not less than \$1,000,000 per accident. The automobile liability insurance coverage amounts may be satisfied with a combination of primary and excess/umbrella coverage. Owner and Authorized Payor shall be named as an additional insurance on said policy.
- 6.12.3 Commercial General Liability. Bodily injury and property damage liability shall protect Engineer performing Work under this Agreement from claims of bodily injury or property damage which arise from operation of this Agreement, whether such operations are performed by Engineer or anyone directly or indirectly working for or on Engineer's behalf. The amounts of such insurance shall not be less than \$1,000,000 bodily injury each occurrence and \$2,000,000 aggregate and \$1,000,000 property damage each occurrence and \$2,000,000 aggregate. This insurance shall include coverage for products/completed operations, personal and advertising injury liability, and contractual liability in an amount not less than \$1,000,000 each occurrence and \$2,000,000 aggregate. The liability insurance coverage amounts may be satisfied with a combination of primary and excess/umbrella coverage. Owner and Authorized Payor shall be named as additional insured on said policy.
- 6.12.4 Professional Liability. Insuring against professional negligence, errors and omissions on an occurrence basis with policy limits of \$2,000,000 per claim and \$2,000,000 annual aggregate.
- 6.12.5 Workers' Compensation. Worker's Compensation insurance shall meet the statutory requirements of the State of North Carolina, even if not required by law to maintain such insurance.

The North Carolina Workers' Compensation Act (the "NCWCA") requires that all businesses which employ three (3) or more employees (N.C.G.S. § 97-2), including those operating as corporations, sole proprietorships, limited liability companies and partnerships, obtain workers' compensation insurance or qualify as self-insured employers for purposes of paying worker's compensation benefits to their employees. An employer is not relieved of its liability under the NCWCA by calling its employees

“independent contractors.” Even if the employer refers to its workers as independent contractors and issues a Form 1099 for tax purposes, the North Carolina Industrial Commission may still find that the workers were in fact employees, based upon its analysis of several factors, including but not limited to the degree of control exercised by the employer over the details of the Work. Owner requires all vendors and contractors working for Owner to provide evidence of worker’s compensation insurance coverage unless excluded from coverage under North Carolina law. By execution of this agreement, Engineer is certifying compliance with the NCWCA.

6.13 DISPUTE RESOLUTION

- 6.13.1 Any claims or disputes arising under this Agreement shall be subject to mediation as a condition precedent litigation. Mediation shall proceed in accordance with the requirements of N.C.G.S. § 143-128(f1).
- 6.13.2 If the Parties cannot reach a resolution using mediation, the Parties may proceed to litigation.
- 6.13.3 This Agreement shall be governed by the laws of the State of North Carolina and proper venue for any claims shall be the State Courts located in Cherokee County, North Carolina.

6.14 HAZARDOUS POLLUTANTS

- 6.14.1 Engineer shall immediately notify Owner in writing if the Engineer becomes aware of the presence of asbestos containing materials and regulated hazardous pollutants located on the Project Site in any form, whether existing or placed upon the Site after the beginning of construction activities.
- 6.14.2 Engineer shall perform the services described in this Contract in a manner to accommodate and facilitate Owner’s activities in identifying, remediating, managing, and removing (including demolition) asbestos containing materials and regulated hazardous pollutants without Additional Compensation.

SECTION 7 – ENTIRE AGREEMENT

- 7.1 This Agreement, and exhibits listed herein, constitute the entire agreement between the Parties and supersedes all prior written or oral understandings. This Agreement may only be amended, supplemented, or modified by a duly executed written instrument.

The following exhibits are attached hereto and incorporated to this Agreement. If there are conflicts between the exhibits attached hereto and this Agreement, this Agreement shall control.

- a. Exhibit A – Engineer’s Proposal
- b. Exhibit B – Engineer’s Hourly Rate
- c. Exhibit C – Engineer’s Certificate of Insurance

SECTION 8– MISCELLANEOUS PROVISIONS AND DEFINITIONS

8.1 MISCELLANEOUS PROVISIONS.

The following miscellaneous provisions applies to this Agreement.

- 8.1.1 Records Retention. Engineer shall maintain on file in legible form, for a period of six (6) years following completion or termination of its services, all documents, records (including cost records), and design calculations related to Engineer's services or pertinent to Engineer's performance under this Agreement, including all expense records regarding Additional Services and Reimbursable Expenses. Upon Owner's request, Engineer shall provide a copy of any such item to Owner at no cost.
- 8.1.2 Notices. Unless otherwise specified in this Agreement, all notices required under this Agreement will be in writing, addressed to the appropriate party as indicate below and given by registered or certified mail postage prepaid, or by a commercial courier service. All notices shall be effective upon the date of receipt.

- 8.1.3 Survival. All express representations, waivers, indemnifications, and limitations of liability included in this Agreement will survive its completion or termination for any reason.
- 8.1.4 Severability. Any provision or part of the Agreement held to be void or unenforceable under any laws or regulations shall be deemed stricken, and all remaining provisions shall continue to be valid and binding upon Owner and Engineer, which agree that the Agreement shall be reformed to replace such stricken provision or part thereof with a valid and enforceable provision that comes as close as possible to expressing the intention of the stricken provision.
- 8.1.5 Waiver. A party's non-enforcement of any provision shall not constitute a waiver of that provision, nor shall it affect the enforceability of that provision or of the remainder of this Agreement.
- 8.1.6 Accrual of Claims. All causes of action arising under this Agreement shall be deemed to have accrued, and all statutory periods of limitation shall commence, in accordance with North Carolina law.

- 8.1.7 Execution in Counterpart. This Agreement may be executed in multiple counterparts, each of which may contain the signatures of one or more parties, all of which, taken together, shall constitute one and the same instrument. Facsimile and/or scanned signatures shall be treated as an original.
- 8.1.9 Conflicts of Interest. Engineer certifies that it is aware of and shall comply with all laws related to conflicts of interest, gifts, favors and the like, specifically including but not limited to N.C.G.S. §§ 14-24 and 133-31 and -32. Engineer hereby certifies it has no undisclosed conflicts of interest with respect to this Agreement, including but not limited to conflicts that may be due to representation of other clients, customer or vendees, other Engineer's other contractual relationships, or any interest in property that Architect may have. Furthermore, Engineer asserts it will not engage in any action that would create a conflict of interest for any of Owner's employee or other person during performance of, or otherwise related to, this Agreement. Should a conflict of interest arise during the term of this Agreement, Engineer shall immediately disclose said conflict in writing to Owner. Violation of this section shall justify immediate termination of this Agreement.
- 8.1.10 No Discrimination. During the performance of the Agreement, all Parties agree not to discriminate against any employee or applicant for employment in terms of initial employment, tenure, terms of employment or otherwise because of race, color, religion, sex, national origin, political affiliation or belief, age, sexual orientation, ancestry, or disability that is unrelated to the individual's ability to perform the duties of a particular job or position, height, weight, or marital status. All Parties will post, when appropriate, all notices related to nondiscrimination as may be required by applicable law. Engineer shall insert a non-discrimination clause in all subcontracts and require the same in any lower tier subcontracts. Engineer shall be responsible for compliance with this provision for its employees and all subcontractors.
- 8.1.11 E-Verify. At all times during performance of this Agreement, the Parties shall fully comply with Article 2 of Chapter 64 of the North Carolina General Statutes and shall ensure compliance by any subcontractors utilized. All Parties shall execute an affidavit verifying such compliance upon Owner's request. Engineer shall not knowingly employ unauthorized alien workers in violation of 8 U.S.C. § 1324a or Section 274A of the Immigration and Nationality Act. Evidence of any such violation by Engineer will be cause for immediate termination of this Agreement by Owner. Engineer shall insert an E-verify clause of substantial similarity to this provision in all subcontracts and require the same in any lower tier subcontracts. Engineer shall be responsible for compliance with this provision for its employees and all consultants.
- 8.1.12 No Waiver of Governmental Immunity. Nothing in this Agreement shall be construed to mandate purchase of insurance by the Owner or to in any way waive Owner's defense of governmental immunity from any cause of action alleged or brought against any Party for any reason if otherwise available as a matter of law. No officer, agent, or employee of OWNER shall be subject to any personal liability by reason of execution of this Agreement or any other documents related to the transactions contemplated hereunder. Such officers, agents, or employees shall be deemed to execute this Agreement in their official capacities only, and not in their individual capacities.
- 8.1.13 Divestment Acts. Engineer hereby certifies that as of the date listed below, it is not on any of the Final Divestment Lists as created by the State Treasurer pursuant to: The Sudan (Darfur) Divestment Act of 2007, as amended; The Iran Divestment Act of 2015, as

amended; or the Divestment from Companies Boycotting Israel Act of 2017, as amended, respectively codified in NCGS §147-86.41 et seq., NCGS §147-86.55 et seq. and NCGS §147-86.80 et seq. Engineer shall not utilize in the performance of this Agreement any subcontractor that is identified on any Final Divestment List.

8.1.14 Force Majeure. Neither party will be responsible for any failure to perform due to causes beyond its reasonable control (each a "Force Majeure"), including, but not limited to, acts of God, war, riot, embargoes, acts of civil or military authorities, denial of or delays in processing of export license applications, fire, floods, earthquakes, accidents, pandemics, strikes, or fuel crises, provided that the party claiming a delay or adverse effect due to Force Majeure gives prompt written notice thereof to the other party. The time for performance will be extended for a period equal to the duration of the Force Majeure, but in no event longer than thirty (30) days.

8.1.15 Public Records. Engineer acknowledges and agrees that Owner is subject to the Public Records Act ("Records Act"), as codified in Chapter 132 of the North Carolina General Statutes. By executing this Agreement, Engineer acknowledges that Owner is obligated to comply with the Records Act, which may be amended from time-to-time, and in so complying, Owner may disclose all information Engineer has provided to Owner, including but not limited to, this Agreement and any correspondence from or to Owner. Pursuant to G.S. 132-1.2(1), Engineer may designate confidential information as a "trade secret" or "confidential" and, upon Engineer's request, Owner will not disclose such records that would otherwise be entitled to protection under G.S. 132-1.2(1). Owner will determine in its sole discretion whether such information is entitled to such protection under the Records Act. Should Owner withhold such information from any public records request at Engineer's request, Engineer shall indemnify and hold Owner harmless from any action or claim brought against Owner that such records are public. Owner shall not be liable to Engineer for disclosing this Agreement, or any documents or communications made or received in relation thereto, to any third party or the public at large, if such disclosure is made by Owner in a good faith effort, within its sole discretion, to comply with any public records request or other applicable laws.

8.1.16 Deleted.

8.1.18 Waiver of Consequential Damages. Owner, Authorized Payor and Engineer waive consequential damages for claims, disputes, or other matters in question arising out of or related to this Agreement. This mutual waiver is applicable, without limitation, to all consequential damages due to either party's termination of this Agreement.

8.1.19 Jessica Lunsford Act. Under North Carolina law, certain sex offenders are prohibited from coming onto school campuses. Engineer agrees to conduct a check of all employees

working at the Project Site on the N.C. Sex Offender and Public Protection Registration Program, the N.C. Sexually Violent Predator Registration Program and the National Sex Offender Registry. As a term of this Agreement, said checks must be performed by Engineer and reported to the Cherokee County Schools Superintendent.

8.2 DEFINITIONS

- 8.2.1 Authorities Having Jurisdiction means any Federal and State governmental organization responsible for enforcing building codes, fire codes, land use codes or any other regulations with respect to the Project at the Site.
- 8.2.2 Contract Documents include, but are not limited to: the Agreement(s) between the Owner and Contractor(s), change orders, construction change directives, payment and performance bonds, certificates of insurance, and the project manual, drawings, plans, and specifications, the general conditions, supplementary general conditions, and special conditions are hereby incorporated into this Agreement as if fully set-forth.
- 8.2.3 Contractor means the selected firm contracted by Owner to perform the Work for the Project.
- 8.2.4 Final Certificate of Payment means that the Work has reach Final Completion and is the final payment, including the release of any retained funds, to Contractor.
- 8.2.5 Final Completion means that all Work and contractual obligations are fully finished, including punch list items, and Owner has formally accepted the Project after a final inspection and the submission and approval of all required closeout documents.
- 8.2.6 Site is Andrews Elementary School located at 205 Jean Christy Ave., Andrews, NC 28901.
- 8.2.7 Substantial Completion means that degree of completion of the Project, improvement or specified area or portion thereof (in accordance with the Agreement, as modified by any Change Orders agreed to by the Parties) upon attainment of which Owner can use the same for the purpose for which it was intended. The date of Substantial Completion shall be established by Engineer in the Certificate of Substantial Completion.
- 8.2.8 Work means the entire scope of Contractor's obligation pursuant to the Contract Documents, which include all labor, materials, equipment and services necessary to complete the Project.

In response to our recent discussions, we are pleased to submit this proposal for your consideration. The roof areas outlined in this proposal include Areas A-D (totaling approximately 47,012 square feet) of the facility located at 205 Jean Christy Avenue, Andrews, NC 28901.

The following is an outline of the proposed services for Contract Documents (CD) and Construction Administration (CA):

I. CONTRACT DOCUMENTS

- A. Conduct the site visit(s) to develop detailed Contract Documents for the subject building.
- B. Extract roof samples to identify roof system composition and condition. Submit samples for testing to determine the presence or absence of asbestos containing materials on each bituminous roof area. Cored locations to be repaired with compatible materials.
- C. Perform the following engineering design calculations for all roof areas which will be sealed by a Licensed Engineer:
 - 1. Determine design wind loads in accordance with ASCE 7 as required by the current edition of the State Building Code.
 - 2. Primary and secondary (overflow) drainage for compliance with the current edition of the State Plumbing Code.
 - 3. Existing and proposed roof system R-Value for compliance with the current edition of the State Energy Conservation Code.
 - 4. Estimate existing and proposed roof system dead load unit weights to determine load change and the need for a structural analysis. If a structural analysis is required, REI will coordinate applicable work with a licensed Structural Engineer. The cost for the structural analysis (if necessary) is not included in this proposal.
- D. Prepare comprehensive scale drawings for conditions present to ensure competitive bids are received. All plans and details to be developed on Computer Aided Drafting (AutoCAD).

- E. Prepare technical specifications for the project.
- F. Issue preliminary Contract Documents for Owner and DPI review. Upon acceptance, final Contract Documents will be prepared and submitted.
- G. Provide advertisement for bids to Owner for use in advertising in accordance with applicable laws and/or submit names of three or more qualified Contractors to bid the Contract Documents.
- H. Hold one Pre-Bid Meeting for potential contractors to review the Contract Documents and resolve any questions that may arise during the bid stage of the project.
- I. Bids shall be analyzed and a recommendation made based on low bid, alternates, contractor's past performance and Owner's budget restrictions. Submit a certified Bid Tabulation and recommendation for award.

II. CONSTRUCTION ADMINISTRATION

- A. Complete Owner's recommended Form of Agreement between Owner and Contractor and submit to Owner and Contractor for acceptance.
- B. Issue "Notice to Proceed" with Date of Commencement and construction period established.
- C. Review and accept submittals required by the Contract Documents, to determine if the items covered by the submittals comply with the requirements of the Contract Documents and are compatible with the design concept of the completed Project. 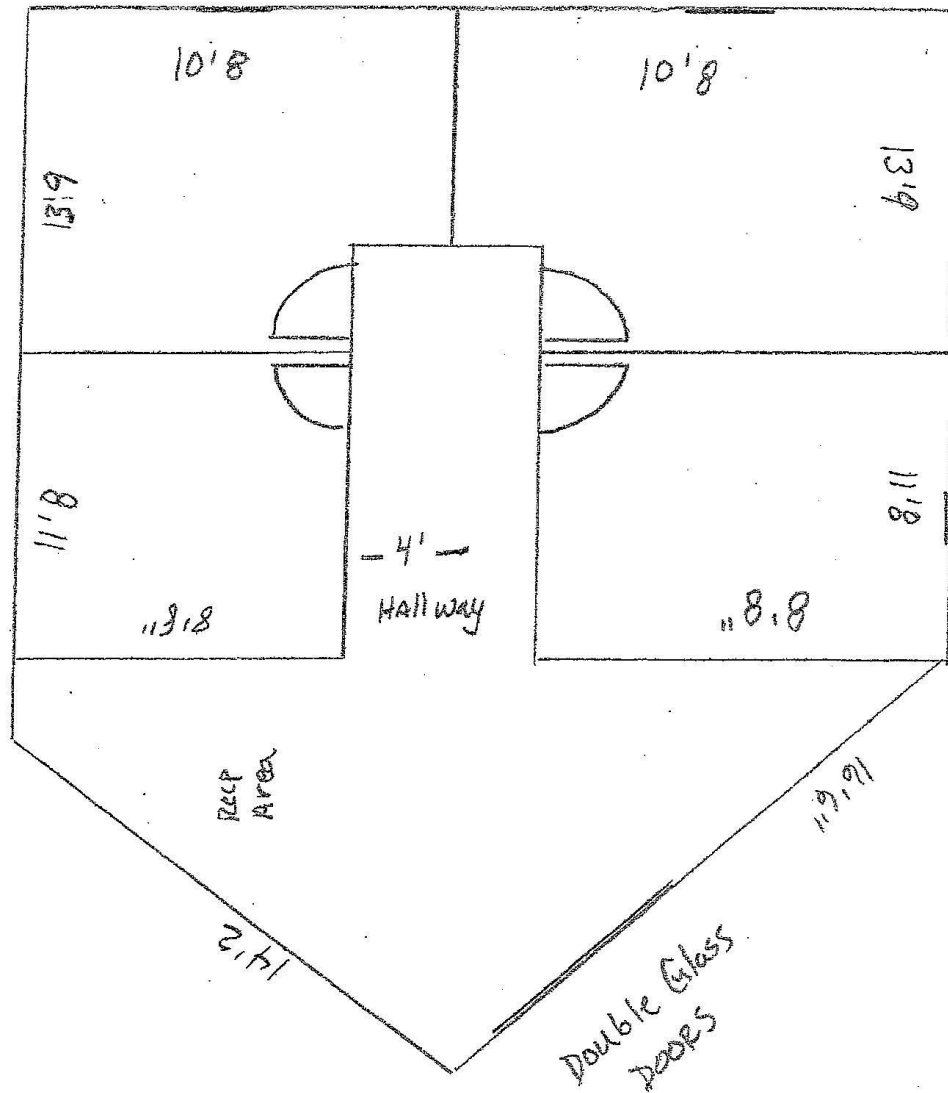

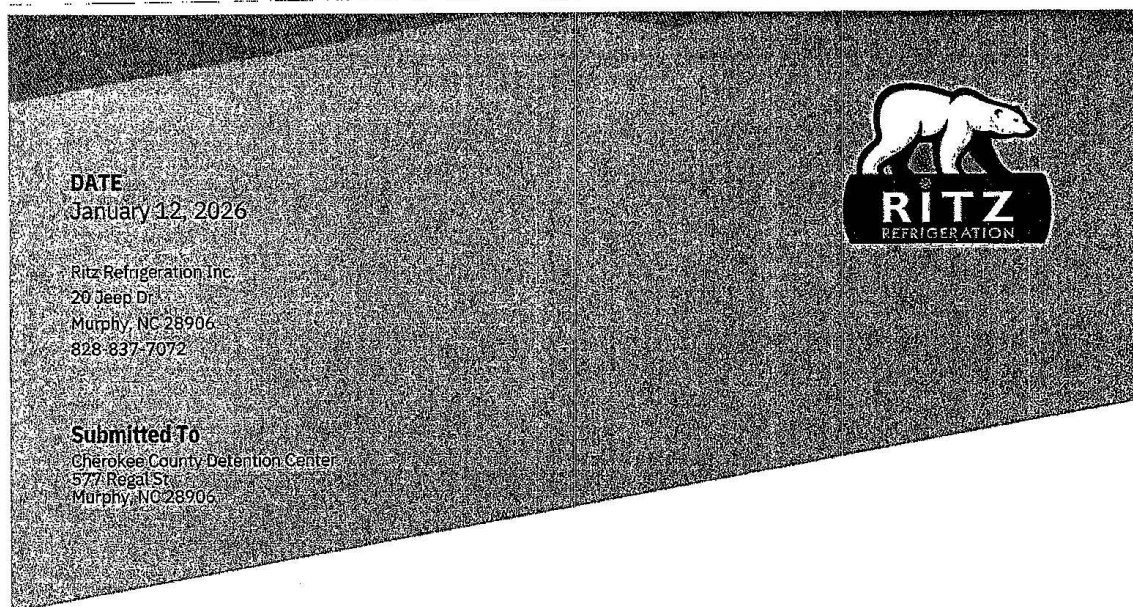

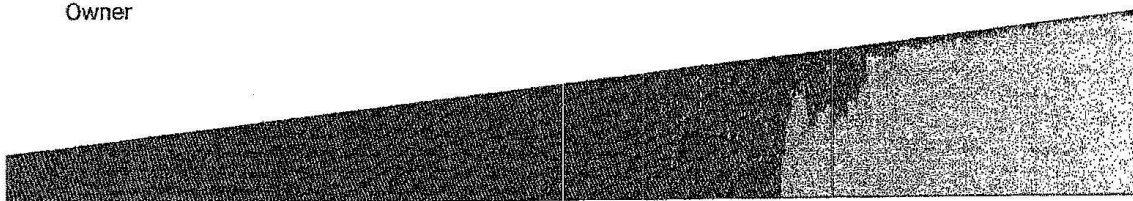

Eligible Applicants:

Local and State (NC) law enforcement, criminal justice and correctional agencies

For local law enforcement agencies, only NCLEA accreditation activities will be supported if:

1. The agency has not started or is in self-assessment phase of NCLEA, and
2. The agency is not started, in the self-assessment phase or fully accredited by CALEA.

CALEA accreditation will not be supported with these funds.

This priority is designed to help agencies start the accreditation process. It is not designed to sustain an agency's accreditation status once it has already been achieved.

Agencies must state their accreditation status in the first sentence of their project Abstract Narrative field in the EBS application: "Our agency attests that we are requesting NCLEA accreditation, that we are not yet fully NCLEA accredited, and that we are not currently in the process of, nor possess, CALEA accreditation."

It is imperative that local law enforcement be trained in sound criminal justice policies, procedures, and live training scenarios. Statewide accreditation standards are one practical way to help achieve this. North Carolina Law Enforcement Accreditation (NCLEA) standards will help raise the level of professionalism among law enforcement agencies. It will also ensure that the public at large is aware that their officers and deputies have received baseline training on how law enforcement officials should conduct themselves.

The budget must explicitly document the direct correlation that the funds are used to support efforts in an agency to achieve these accreditation standards. Funds can be used to pay for:

- ♦ accreditation fees,
- ♦ overtime to achieve these standards (documented by time and activity sheets),
- ♦ supplies needed to support the accreditation efforts (not supplies for general use),
- ♦ assistance in reviewing and improving agency policies and procedures,
- ♦ required training to meet accreditation, and
- ♦ any other cost that can be clearly documented for the accreditation efforts,
- ♦ Construction costs are not permissible.

Note: Any other items that are listed in the application that do not have a direct connection and impact on achieving accreditation status may cause this application to be not considered for funding. Funds will not be used as an overtime supplement or a travel fund. Applications that are unable to clearly demonstrate this need will not be considered.

LAW ENFORCEMENT FAQ:

Q: What documentation is needed for overtime reimbursement?

A: Law enforcement agencies with overtime enforcement grants must submit a claim that includes the following documentation: an overtime calendar, the officer's regular work schedule, payroll report or copy of general ledger, paycheck details for each officer, CAD (computer automated dispatch) reports for every shift, and copies of citations issued during each shift.

Grant Program Background

The Byrne JAG funds

The Edward Byrne Memorial Justice Assistance Grant (JAG) Program is the leading source of federal justice funding to state and local jurisdictions. The JAG Program provides states, tribes, and local governments with critical funding necessary to support a range of program areas including law enforcement, prosecution, indigent defense, courts, crime prevention and education, corrections and community corrections, drug treatment and enforcement, planning, evaluation, technology improvement, crime victim and witness initiatives, mental health programs, and related law enforcement and corrections programs, including behavioral programs and crisis intervention teams, and implementation of state crisis intervention court proceedings and related programs or initiatives including, but not limited to, mental health courts, drug courts, veterans courts, and extreme risk protection order programs.

The RSAT funds

The Residential Substance Abuse Treatment (RSAT) Program is a formula grant program that enhances the capabilities of state, local, and tribal governments to provide residential substance use disorder (SUD) treatment to adult and juvenile populations during detention or incarceration, initiate or continue evidence-based SUD treatment in jails, prepare individuals for reintegration into the community, and assist them and their communities throughout the reentry process by delivering community-based treatment and other recovery aftercare services.

The RSAT Program encourages the establishment and maintenance of drug-free prisons and jails and development and implementation of specialized residential SUD treatment for individuals with co-occurring mental health and substance use disorders. The program also encourages the inclusion of medication-assisted treatment as part of any SUD treatment protocol.

The Byrne SCIP funds

As authorized by the Bipartisan Safer Communities Act of 2022, the Byrne State Crisis Intervention Program (Byrne SCIP) provides formula funds to implement state crisis intervention court proceedings and related programs or initiatives, including, but not limited to, extreme risk protection order programs that work to keep guns out of the hands of those who pose a threat to themselves or others, mental health courts, drug courts, and veterans treatment courts. SCIP funds will be utilized to help educate on gun safety, expand threat assessment teams through training and tools, expand recovery and crisis courts, establish, and support local behavioral programs and support local law enforcement with subscriptions for access to mental health services.

Compliance with Federal Rules Regulating Grants

Agencies that receive funding from the Governor's Crime Commission must comply with all provisions of the Federal Program Guidelines, and the administrative requirements, cost principles, and audit requirements of the Uniform Guidance set forth in 2 C.F.R. § 200.

2026 RESOLUTION ESTABLISHING A SPECIAL BOARD OF
EQUALIZATION AND REVIEW

WHEREAS, North Carolina General Statute (NCGS) 105-322 directs that the members of the Cherokee County Board of Commissioners are the Board of Equalization and Review for the county.

WHEREAS, NCGS 105-322(a) provides that the Board of Commissioners are authorized to create a special board of equalization and review (BOER) to carry out the duties imposed under Article 21 of Chapter 105 of the North Carolina General Statutes.

WHEREAS, the Cherokee County Board of Commissioners deems it advisable to appoint a special Board of Equalization and Review and by this resolution provide for the membership, qualifications, terms of office and the manner of filling vacancies on the special Board of Equalization and Review.

THEREFORE, BE IT HEREBY RESOLVED, by the Cherokee County Board of Commissioners as follows:

1. That all previous resolutions regarding the special Board of Equalization and Review are hereby repealed.
2. That the Cherokee County special Board of Equalization and Review is hereby established pursuant to NCGS 105-322(a).
3. That the special Board of Equalization and Review is authorized to exercise all powers and duties as prescribed in Article 21 of Chapter 105 of the North Carolina General Statutes
4. Terms - The BOER shall consist of 5 members and 1 alternate who shall serve a term of 1 year beginning on January 1 and terminating on December 1.
5. Vacancies - Vacancies on the BOER that result in less than 5 members able to timely execute the duties of the BOER shall be filled at the next regular meeting of the Cherokee County Board of Commissioners unless an emergency or special meeting of the County Commission is necessary for the expedient continuation of the business of the BOER. The filling of a vacancy shall be exempt from the County Commission Rules regarding Board appointments. Vacancies on the BOER shall be reported by the Tax Assessor to the Clerk to the Board of Commissioners no later than 48 hours of the time of the vacancy.

6. Compensation- Sitting members of the BOER shall be compensated at a rate of \$125.00 per regular member and \$150.00 for the Chair per meeting of the BOER *unless the member indicates to the Cherokee County Finance Office that they wish to volunteer his/her service.*

7. Re-adoption - The Clerk to the Board of Commissioners shall hereafter place on the agenda of the first regular meeting of the Board of Commissioners in January of each calendar year the reconsideration of this resolution, including membership and compensation.

8. Nominations for membership on the BOER shall be submitted to the Board of Commissioners by the Tax Assessor at the first regular meeting of the Board of Commissioners in December of the year prior to the year of service. Any citizen of Cherokee County may nominate themselves for membership on the BOER at that meeting.

9. Qualifications:

1. Each member of the special Board of Equalization and Review shall be a resident of Cherokee County and shall remain a citizen and resident of Cherokee County for the entirety his/her service.
2. Each member shall have paid all Cherokee County taxes currently owed.
3. Each member shall be of good moral character.
4. Each member shall not have been convicted of a felony or a misdemeanor involving moral turpitude.
5. Each member shall be familiar with the Board of E&R Handbook and shall adhere to all ethical standards prescribed therein.
6. The Tax Assessor shall certify a report of these qualification criteria for all prospective members of the BOER to the Clerk to the Board of County Commissioners no later than December 31.

10. For 2026 the Cherokee County Board of Commissioners appoints the following members of the special Board of Equalization and Review:

Alex Starks

Christine Standish

Jerry Decker

Teresa Oblenes

Russ Worthen

11. The Board of Commissioners appoints Teresa Oblenes as Chair of the 2026 BOER.

12. Removal from Office: Any member of the Special Board of Equalization and Review may be removed by a majority vote of the Cherokee County Board of Commissioners for:

- A. Being convicted or charged with a felony or misdemeanor involving moral turpitude in any jurisdiction.
- B. For conduct unbecoming to the office, or engaging in any conduct or making statements that may bring the office into disrepute.
- C. For failure to abide by applicable ethical standards.
- D. Failing to maintain citizenship and residence within the confines of Cherokee County.
- E. Repeated failure to attend meetings of the Board.

13. Power to Compromise as set forth in NCGS 105-312(k) shall be vested in the Board of Commissioners through the County Attorney.

14. Pursuant to NCGS 105-322, it is ordered and decreed that the special Board of Equalization and Review is authorized and ordered to re-convene for such times as they are needed to execute duties set forth in NCGS 105-322(g)(5) until the end of calendar year or until further action of the Board of Commissioners. It is further authorized for the County Attorney to advise and act as counsel to the special Board of Equalization and Review at such times as the board deems necessary

15. Should any provision of this resolution be declared invalid, unlawful or unconstitutional by any court of competent jurisdiction, such declaration shall not affect the validity of the remainder as a whole or any part thereof which is not specifically declared to be invalid, unlawful or unconstitutional.

16. The Clerk to the Board of Commissioners shall forward this resolution to the NC Department of Revenue in accordance with NCGS 105-322(a).
