## Approval of:

- a) **Approval of minutes:** Members reviewed and approved the minutes for the May 8, 2017 meeting. Jeff Martin made the motion to approve the meeting minutes Brett Nourreier seconded the motion. The motion carried.
- b) HIPPA Policy: The Board reviewed the amended HIPPA compliance policy that was expanded to include use of the electronic health record and to make it more comprehensive and useful in administering the requirements of the law. The Board wanted to clarify that it would not require us to acquire software before approval. CB McKinnon made the motion to approve the policy Mike Bradberry seconded the motion. The motion carried.
- c) Complaint Policy: The complaint policy is a newly developed policy to supplement the HIPPA policy and formalize a system for complaints to be filed and reviewed by the appropriate personnel within the Health Department. The Board discussed that the policy was developed to serve as a complaint mechanism for all types of complaints not just complaints related to HIPPA. We discussed that the complaint policy is referenced in the HIPPA policy. Mike Bradberry made the motion to approve the policy Grady Hester seconded the motion. The motion carried.
- **d) 340 B Purchased Drug Policy:** The 340B policy was presented for approval to as part of our annual policy review to ensure compliance with the 340B Federal Drug pricing program. The Board had no questions about the policy. Brett Nourreier made the motion to approve the drug policy John Hyer seconded the motion. The motion carried.
  - i. A supplemental fee schedule was presented for approval that meets the requirements of the 340B pricing program for IUD's in accordance with the 340B rules. Brett Nourrcier made the motion to approve the fee schedule as presented Mike Bradberry seconded the motion.

e) Drug Screen Fees: A new fee schedule was presented for new drug screen options that are utilized at the request of our consumers. CB McKinnon made the motion to approve the drug screening fees Jeff Martin seconded the motion.
